# 2015 OKNRC Awards

We want to take this opportunity to update you on last year's annual meeting held during the 2015 Oklahoma Natural Resources Conference (OKNRC) and provide you information about the 2016 OKNRC.

In 2015, the OCTWS joined the Oklahoma Chapter of the American Fisheries Society to form the OKNRC. The first annual meeting was held in Tulsa during February. Approximately 200 professionals and students representing over fifteen different entities enjoyed presentations which encompassed a variety of topics. Numerous state and federal agencies and NGOs presented research and program updates. The diverse makeup of attendees and entities represented provided a unique networking opportunity for those involved.

During the 2015 OKNRC, the OCTWS presented several awards: Oklahoma Award, Private Land Management Award, Publication Award, Moser Award, and the Student Research Presentation Awards.

## The Oklahoma Award

The Oklahoma Award was presented to Jontie Aldrich. Jontie has been very instrumental in wildlife conservation efforts during his 35 years in Oklahoma. As a result of Jontie's work and dedication, Oklahoma's natural resources have improved and flourished for future generations of sportsman to enjoy. Jontie has dedicated himself to working throughout the state of Oklahoma, developing long term partnerships with many agencies, schools, and landowners.

Jontie graduated from Michigan State University in 1976 with a Bachelor's of Science Degree in Wildlife Management. After briefly working for the Michigan Division of Natural resources, he came to work for the Oklahoma Department of Wildlife Conservation as a Waterfowl Biologist from 1980 to

1991. From 1991 to 2015, Jontie was employed by the U.S. Fish and Wildlife Service as the State Coordinator for the Partners for Fish and Wildlife program. He served as the acting Field Supervisor for the Tulsa Ecological Service Office until he retired.

## Distinguishing Activities

In the 1980's, Jontie led a group of young boys across the Oklahoma landscape and then across the nation. During this time, Jontie's Explorer Post 637 was able to discover many types of ecosystems by walking, canoeing or by boat. He opened several young men's eyes to the wonderful outdoors and hunting and fishing.

Jontie's position as the waterfowl biologist at ODWC provided one of his largest contributions as a biologist: the giant Canada Goose Program. This program was a huge success story for the ODWC. Jontie coordinated this effort from the beginning until the final trip with geese was completed. This has provided sportsmen, bird watchers, photographers and outdoor enthusiasts a critter to enjoy in many ways here in Oklahoma.

In the 1980's, Jontie was working statewide to improve wetland habitat on public hunting areas, and was the first to deal with the Corps of Engineer on these projects along with other conservation organizations across the state. This effort was the start of thousands of acres enhanced and developed on public lands across the state in which sportsman are still enjoying today. During this time, Jontie was also instrumental in the very first stages of mapping out and attending meetings regarding the proposed Deep Fork National Wildlife Refuge. Eventually, this effort became a reality.

In 1991, Jontie was hired by the U.S. Fish and Wildlife Service as the State Coordinator for the Partners for Fish and Wildlife Program. Over the past 24 years, he has developed a working relationship between several state and federal agencies. The Partners program has played a role in various influential projects in Oklahoma such as Hackberry Flat, Grassy Slough and several wetland reserve program sites across the state.

has coordinated and developed over 142 outdoor classroom projects designed to share with young school children the importance of all our natural resources. Oklahoma now has more outdoor classrooms projects than any other state. This is a great accomplishment! Jontie has been recognized by the Oklahoma Department of Wildlife Conservation and the Oklahoma Conservation Commission as a result of the partnerships that have been built between the agencies over the past 24 years. Jontie has developed agreements for prescribed fire with Oklahoma Conservation Commission as well as funding for the ODWC Wildlife Habitat Improvement Program. This was a first in developing these partnerships and kept Oklahoma on the leading edge for USFWS in Region 2.

## The Private Land Management Award

The Bluestem Ranch was presented the Private Land Management Award. The Bluestem Ranch consists of 43,433 acres located twelve miles east of the town of Fairfax in Osage County, Oklahoma. The Bluestem Ranch was purchased by Turner Enterprises, Inc. in March of 2001. The ranch is managed by John Hurd.

Before Mr. Turner purchased this ranch, wildlife management was not a concern on the property and it was managed as a working cattle ranch.

Deer hunting pressure was heavy and unregulated across the ranch. Quail and Rio Grande turkey populations were very low due to overharvest and high frequency burning. Herbicides were applied across the entire ranch each year for livestock (stocker) production. The pastures averaged around 320 acres in size at the time of purchase.

Mr. Turner introduced a new style of land management for this ranch. This ranch is now grazed with yearling buffalo that are shipped in from other Turner owned ranches. Most of the yearlings are grazed on this ranch for about 20 months with the heaviest stocking numbers present during the growing season. Fence removal and fence construction have increased pasture size on the ranch. Currently, the average pasture size on the ranch is estimated at around 900 acres. The ranch can sustain approximately 6,500 to 7,000 yearling buffalo but the ranch has been stocked at the rate of 5,000 yearlings for the past four years. The grazing style of the buffalo, introducing patch style burning, and reduced herbicide spraying has provided excellent habitat structure for bobwhite

quail, deer, and other wildlife species. During the past two years, some cattle grazing was implemented to remove excess grass growth in some areas of the ranch.

A total of 14 new ponds have been constructed or rebuilt during the past 9 years. These ponds have been stocked with fish from the Oklahoma Department of Wildlife Conservation (OWDC) with some additional fish purchased from Dunns Fish Farms.

Over the past 12 years, the Bluestem Ranch and the ODWC continue to bring a 2 ½ day youth doe deer gun hunt to the area. Youth who are drawn under the ODWC draw program are able to participate in a controlled youth deer doe hunt during the first weekend of October. The Bluestem Ranch is now the longest running private ranch in the state who continues to participate with ODWC in the youth hunt draw program. The Bluestem Ranch is also leased for hunting and fishing. For the past 12 years, the Ranch has also participated in the Deer Management Assistance Program through ODWC to increase the number of quality bucks on the ranch while harvesting enough does to maintain a good buck-to-doe ratio.

The Bluestem Ranch is a working ranch with bison and cattle grazing on parts of the ranch year-round. The rangeland across the ranch is in excellent condition. Each year the ranch will incorporate prescribed fire in areas of the ranch to control brush invasion and maintain wildlife habitat.

Mr. Hurd supports wildlife habitat improvements by good grazing management, proper use of prescribed fire, constructing food plots, constructing quail feeders, helping coordinate a wetland development construction project with contractors, providing bulk feed truck to fill quail feeders, continuing to control the expansion of the feral hog population on the ranch and helping to

reduce wildlife poaching on the ranch.

Mr. Hurd has donated two to three bison each year to ODWC for the Wildlife Expo event at the Lazy E Arena. This past spring and summer, Mr. Hurd also supported the "Grassland Bird Monitoring in Focal Counties" which is an annual survey route that is conducted across the Bluestem Ranch to monitor grassland birds. This survey was supported and developed by the Oaks and Prairie Joint Venture with additional support from Oklahoma State University. Mr. Hurd participates in local FFA events and supports schools as needed in efforts and activities that involve ranching and outdoor issues that young kids can participate in.

# From the Editor's Stand...

The first major cold front pushed through a few days ago, bringing high winds, multiple large-scale wildfires and migratory birds.

While sitting in a parking lot eating lunch, I watched a puff of smoke rise to the west, then to the east, and as those two fires blew up, two more followed to the northwest and a smaller to the southeast. Fire departments, landown-

ers, ranchers and farmers were stretched thin on Wednesday, November 11th. With the largest fire totalling 17,000 acres, others also totalled around 8,000 acres or more in size. Winter forage, baled hay, barns, homes and livestock were lost in the fires. While this is a community that is very pro-fire, it is still hard to watch wildfires run in 45 mph winds. They just couldn't catch the head fire.

The migratory birds took advantage of our first large front. This morning the lakes were covered with smoke on the water from fires still burning west of here, along with a great number of waterfowl. While the front brought devastation to many, it also provided a great opportunity for wildlife.

As mentioned earlier the OCTWS has a few awards and scholarships we present at our meetings. We have included information about each one below if you would like to apply or know someone to nominate.

### Oklahoma Award

The Chapter's most prestigious award, the Oklahoma Award recognizes individuals who have made outstanding contributions to the profession of wildlife management in the State of Oklahoma.

### Harold C. Stuart Conservation Excellence Award

This award recognizes a lay person or group that has contributed significantly towards enhancing conservation stewardship and perpetuating a conservation ethic through activities in Oklahoma.

### Private Land Management Award

The purpose of this award is to recognize exemplary contributions to natural resource management on private land. Nominations should include descriptions of the landowner's goals, property, and wildlife management practices. The nominator should be prepared to give a brief slide presentation about the recipient and the property at the annual meeting. Nomination letters can include photos, maps, and any other documents needed to support your nomination."

### General criteria to be used for nominations for the Private Land Management Award, the Harold C. Stuart Conservation Excellence Award, and The Oklahoma Award :

1. A nominee should live or work in Oklahoma or have done so during period pertinent to the nomination.
2. A nominee may have received professional training or be a layman in the field of wildlife management.

3. A nominee is not required to be a member of The Wildlife Society or the Oklahoma Chapter.
  4. A nominee's achievement need not have occurred in the 12 months prior to the date his accomplishments are recognized.
- The information for nominations should include:
1. Name, title.
  2. Education – place, degree(s).
  3. Pertinent Employment – past and present, place and dates.
  4. Distinguishing activities (may include papers).
  5. Reason for which nomination is being made.
  6. Signature of nominator.

\*Entries are due by December 30, 2015. Submit nominations in writing via an electronic letter to Craig Davis (craig.a.davis@okstate.edu). For further information, contact Craig Davis.

#### **Publication and Creativity Award**

This award is presented to member(s) of the Oklahoma Chapter who, as individuals or members of a team, make outstanding contributions to natural resource management and conservation through books, technical articles, popular articles, videos, or other media or programs completed within the last 3 years, including the current year. This award is presented annually if a suitable candidate(s) is/are available.

Categories include:

1. Books
2. Electronic Media (i.e. websites, CDs, DVDs, listservs, or similar)
3. Peer-reviewed Scientific Articles (journal or peer-reviewed proceedings)
4. Popular Articles (published in magazines, newspapers, newsletters, or similar)
5. Technical Publications (reports, books, fact sheets, or similar)

Nomination should include: 1) a cover letter supporting the publication, and 2) four hard copies or a digital pdf. Send your nomination for the Publication and Creativity Award in the form of an electronic letter and any other documents needed to support your nomination to Craig Davis (craig.a.davis@okstate.edu, 008C Agricultural Hall, Stillwater, OK 74078). For further information, contact Craig Davis. Entries are due by December 30, 2015."

#### **Student Research Competition**

To recognize and reward undergraduate and graduate students who conduct outstanding research in natural resource ecology and management.

Awards (cash and plaque):

- 1st place: \$500
- 2nd place: \$200
- 3rd place: \$50

Eligibility: Graduate and undergraduate students are eligible. Students who have graduated since the last OCTWS or OKSRM meeting are eligible if they are members of OCTWS or OKSRM at the time of the annual meeting. Students must be the senior author of the abstract and oral presentation. The work being reported must be primarily that of the student. Research projects should be based on at least one season or year of data collection. Only students who are affiliated with an Oklahoma college or university at the time of research OR students who conducted field work in Oklahoma, but are affiliated with an out of state college or university, are eligible to compete. 
