### **Style**

*The Wildlife Professional* is a hybrid of scholarly and magazine-style writing. Articles should present sound, scientific information and be written in a highly readable news magazine style rather than the strict scholarly style used in peer-reviewed scientific journals. Authors should convey information in a way that is understandable and accessible to readers who are not expert in the article topic and include references to peer-reviewed and/or related literature to support the article's content.

## **Review**

Articles submitted for publication are reviewed primarily by the Editorial Advisory Board and other experts to ensure completeness, timeliness, relevance and acceptability for publication. Authors have final responsibility for the accuracy of the article's content.

Before publication, the magazine's editors copyedit articles. This ensures that all content is consistent with the magazine's style and format, which is based on the writing standards of the Associated Press. Authors review the revised article for accuracy before publication. Staff editors work with authors to resolve grammar and style questions; however, the editors have the final decision on such matters. We strongly encourage authors to review past issues of *The Wildlife Professional* for a sense of how to write articles that meet the publication's mission and style.
