## Training Announcement

### Climate Academy *ALC3193*

This **6 month online** course is designed to cover the fundamentals of climate science, provide tools and resources for climate adaptation, and increase climate literacy and communication. Beginning in February 2015, a webinar session will be held every other week for 5 months for a total of 10 sessions (participants will be asked on the application what day and time of the week is best for a 1.5 hour webinar session). Pre-webinar assignments, class resources and discussion forums will be accessed through Moodle, a distance learning platform (no special software required). Course participants will then develop a final product (such as a report or presentation) addressing climate change in their management of natural resources.

The course was developed in partnership with staff from the USFWS's NCTC, The Wildlife Society (TWS), the Association of Fish and Wildlife Agencies (AFWA), the National Park Service (NPS), and the California Department of Fish and Wildlife (CDFW). The course is revised each year through the continued coordination between USFWS, NPS, TWS, AFWA, CDFW, Minnesota Department of Natural Resources and the Society for Conservation Biology.

**\*You will be required to complete an additional application after you register in DOI Learn before you are officially enrolled in the class. This 5 question application will be emailed to you after you apply in DOI Learn and must be completed in order to be considered for enrollment.**

### Objectives

At the conclusion of this course, participants should be able to:

- Explain the scientific basis of climate change
- Understand biological impacts of climate change
- Understand the role of vulnerability assessments and select decision support tools
- Identify principles of adaptation planning and examples of adaptation action
- Effectively communicate climate change impacts to co-workers, stakeholders and management
- Develop a final project that integrates climate change into work
