SDTWS – Executive Board Meeting Minutes September 19, 2012

Runia called the meeting to order at 7:15 PM at Camp Bob Marshal. In attendance were Rocco Murano, Mark Norton, Nathan Baker, Silka Kempema, and Casey Mehls, the newly appointed fund raising committee chair.

Minutes from the last meeting were distributed and reviewed. Travis noted that the thank you letters for meeting sponsors were completed and sent. Mark made a motion to accept the minutes, Rocco seconded. Without any further discussion, Travis called for a vote. The motion passed unanimously.

No treasures' report was prepared as the position is currently vacant. Silka and Travis will set up a meeting with Nora, the previous treasurer, to discuss the duties of the position.

Travis indicated he had received two funding requests. One request was from the student chapter at SDSU for \$1,000 for expenses related to sending 11 students to the National TWS meeting in Oregon. Travis indicated this request is consistent with previous requests from the student chapter that were funded. Rocco motioned to approve, seconded by Mark. Travis called for a vote and the funding request was unanimously approved. Travis will get the \$1,000 paid.

The second request was from Jordan Kitts (SD GFP) for \$250 to sponsor the upcoming federal aid coordination meeting in spring 2013 which the SD GFP is hosting. The sponsorship would go towards a meal or small gift for attendees. The meeting is attended by state federal aid coordinators and delegates for the USFWS' Wildlife and Sport Fish Restoration Program. The goal of the meeting is to make sure the grant process continues to go smoothly. Discussion among the group followed. Silka motioned to table the request so the board can determine whether the request fits in our guidelines. Rocco seconded. The group agreed to act on this request via email in the coming weeks after further discussion. Travis called for a vote and the motion carried unanimously.

Discussion followed about the vacant secretary/treasurer position. Silka emailed Nora to schedule a meeting to discuss the position. Travis suggested making it two positions with alternating terms so there is always an experienced person to teach the position to the new person. Travis will check the bylaws about splitting the position. Mark decided to take on the secretary/treasurer position in the interim.

Travis discussed the Google Drive site that he and Silka have been working on. Many documents have been uploaded. The goal is to have all documents on this site. The board was encouraged to view the progress and review as necessary.

Silka indicated she had signed the UBS investment account document that would allow for the money to be transferred from the account to our Wells Fargo account. She will get it faxed ASAP, then work with Wells Fargo and Susan to put her name on the Wells Fargo account, and drop Susan's name.

The new meeting handbook that Silka put together was briefly discussed. All good feedback.

There was discussion about the gun raffle for the 2013 meeting. Travis will look up how many tickets were sold last year to help determine how much we should spend on a gun and still make money. Travis suggested spending around \$200 on a gun or a print. The rest of the board liked the idea of a gun raffle. Casey will look into finding a gun by first soliciting the membership for a donated or reduced price gun, or look into new guns.

Silka indicated she will send out first call for abstracts in the beginning of December. Silka indicated she would take suggestions on a keynote speaker if anyone has any ideas.

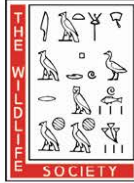
Rocco moved to adjourn meeting, motion seconded by Silka. Travis called for a vote and motion carried unanimously.

Founded in 1936 as The Society of Wildlife Specialists, The Wildlife Society (TWS) has evolved into an international nonprofit organization of professional wildlife ecologists and managers. Members number over 9,000 from 40 different countries and include administrators, biologists, conservation officers, educators, managers and researchers. The objectives of TWS are to:

1. Promote sound stewardship of wildlife resources and the environments upon which wildlife and humans depend;
2. Undertake an active role in preventing human-induced environmental degradation;
3. Increase awareness and appreciation of wildlife values; and
4. To seek the highest standards in all activities of the wildlife profession.



The South Dakota Chapter of TWS (SDTWS) was initiated on February 19, 1966 with 56 charter members. SDTWS is affiliated with the Central Mountains and Plains Section, one of 7 subdivisions of TWS.

Chapter Meetings and Activities

The full membership of SDTWS meets annually in the spring to exchange scientific information through presented papers, debate current issues in wildlife management and land use, and conduct chapter business. The chapter's Executive Board of Directors, consisting of President, Past-President, President-Elect, Secretary-Treasurer, and two standing board members meet at least 4 times each year to discuss issues that do not require full chapter approval. The chapter also communicates with its membership through a newsletter, The Prairie Voice, published within 30 days of Executive Board meetings. The newsletter includes board meeting minutes, committee activity reports, a summary of chapter correspondence, updates on professional conferences, and profiles of chapter members.

Grassland Issues Committee

One highly significant item that requires everyone's immediate attention is **HB1007** in the current legislative session. **HB1007** would limit conservation easements to a period of no more than 30 years. There was a similar bill introduced last year which took considerable time and effort by many individuals and organization to defeat. There have been bills introduced in 2011, 2005, and 2004 with the comparable intent. As the South Dakota landscape continues to change, perpetual conservation easements will play an increasingly important role in habitat protection. In addition to habitat protection, donated permanent easements afford tax incentives for landowners whereas any duration less than permanent does not. Every TWS member needs to follow this bill and be prepared to contact their representative in opposition to it. A good way to keep apprised of this bill and other bills is to utilize the South Dakota Wildlife Federation Camo Coalition website <http://www.sdwfcamo.net/>. Sign up for daily updates and do your part as a South Dakota voter to let your voice be heard.

Wildlife Diseases Committee

Chronic Wasting Disease (CWD): From July 1, 2012 to January 1, 2013 a total of 209 samples (111 elk, 21 mule deer, and 77 white-tailed deer) were collected from southwestern South Dakota, northeastern South Dakota, and the Black Hills of South Dakota. As of January 1, 2013 all results are in, and we have found 2 CWD positive elk, 6 CWD positive white-tailed deer, and 1 CWD positive mule deer. Since testing began in 1997, South Dakota has documented 226 cases of CWD (69 elk and 157 deer) in free ranging deer and elk. Wind Cave National Park accounts for 52 of these animals (42 elk and 10 deer). Custer State Park has found five elk and one deer. A total of 24,839 wild deer and elk have been tested for CWD since 1997.

This fiscal year marked a change in our surveillance with the ending of USDA APHIS funding for CWD surveillance. We are collecting all elk samples as we have in the past, but only sample deer heads from CWD units that are submitted to the Rapid City Regional Office. We continue to test any suspect animals from across the state.

Epizootic Hemorrhagic Disease: In the late summer and fall of 2012, we experienced the largest die-off of in recent history of white-tailed deer in South Dakota. A few mule deer were also reported, and a couple of elk were diagnosed with EHD. Mortalities were reported in 51 counties of South Dakota with large die-offs in the southeastern, central, and western parts of South Dakota. Approximately 3,714 total deer were found dead, with more that were probably unreported. A total of 15 counties had laboratory confirmed cases of EHD with 2 cases of confirmed Blue tongue. It was an historic year for this disease all across the country this year with large die-offs reported in many states.

Pneumonia in Bighorn Sheep: SDGFP is concluding research through SDSU on bighorn sheep. We have captured bighorn sheep lambs over the last 3 years, and have wrapped up that portion of the study. Preliminary data continues to show that lamb recruitment is low in all of our herds in the Rapid Creek, Spring Creek, and Hill City herds. We are experiencing some early predation on our lambs, but pneumonia is a very large factor in lamb survival. We have documented the pneumonia complex in our adult bighorns, and have experienced some adult mortality due to pneumonia. We look forward to the final report and analysis.

Tuberculosis: Bovine TB was found in a Hutchinson county cattle herd in 2011. We have been working with the State Veterinarian to monitor for the disease in wild cervid populations. Samples were collected from deer in 2011, and an attempt was made again in 2012, but EHD reduced our deer populations, and with the reduction in tags, we did not collect many samples. Staff knows what to look for, and we are looking for any abnormalities in harvested cervids to monitor for the disease in our cervid populations. We have not found anything in our deer or elk that would suggest that TB is in the wild cervid populations in any area around these cattle operations.

Other: Diseases that we are aware of and monitoring for in South Dakota include White Nose syndrome in bats, plague in prairie dogs, rabies, and west nile virus. A lot of this monitoring is done through the South Dakota Department of Health, and we work well with the Animal Industry Board on other disease issues.

Wildlife Diversity Small Grants Program

The South Dakota Department of Game, Fish and Parks is currently accepting proposals for funding through the Wildlife Diversity Small Grants Program. This program provides funding for researchers, educators and naturalists to carry out projects focused on native wildlife.

In 2013, the Small Grants Program will focus on education and outreach projects. Native wildlife species and their habitat should be the emphasis of the proposed project. Project awards are limited to \$5,000.00 per applicant or organization. A total of \$35,000.00 is available.

Applicants may submit proposals in word processed, typewritten, or handwritten format. A panel of wildlife and education professionals will evaluate projects.

State Wildlife Grants – Project Spotlight

Determination of river otter distribution and evaluation of potential sites for population expansion in South Dakota

The river otter is a state threatened species in South Dakota. SDGFP recently completed a five-year management plan for the river otter: <http://gfp.sd.gov/wildlife/management/plans/docs/OtterPlan2012.pdf>. Based on accidental captures by beaver and wildlife damage management trappers, road kill records, and observations of live animals, the population is increasing in the state. To better determine current status and distribution, SDGFP has partnered with Dr. Wayne Melquist, a furbearer expert with extensive river otter experience. Dr. Melquist is updating river otter occupancy status of sites with evidence more than 5 years old, determining occupancy of additional drainages, and evaluating sites for suitability as reintroduction or translocation sites. SDGFP does not delist a species from state protection without an abundance of defensible data. Results from this effort will help the agency design a responsible management course of action for this furbearer. This project began in October 2011 and concludes in December 2014.

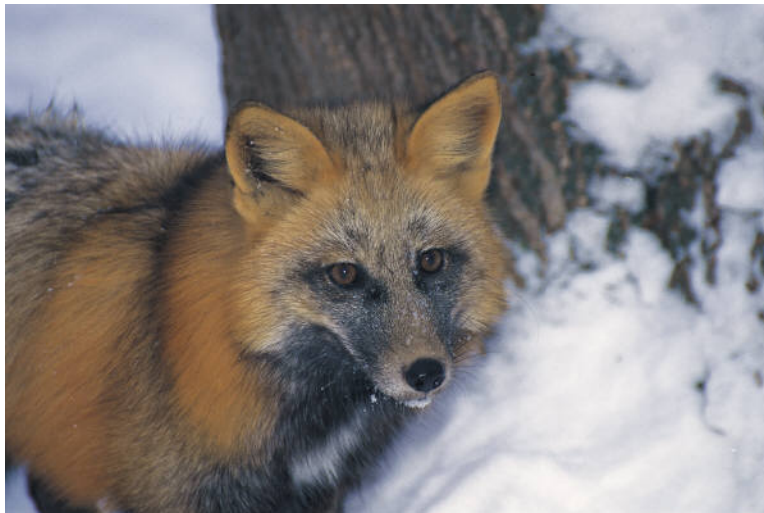
