However, this skill set may be one of the most challenging for a wildlife professional to develop and maintain. Interacting with just one family member, friend or member of the general public on topics of conservation concern provides the opportunity to inform.



SDTWS – Executive Board Meeting Minutes September 17, 2013

Attendance: Silka Kempema, Mark Norton, Casey Heimerl, Nathan Baker, Travis Runia, and Troy Grovenburg

Silka called the meeting to order at 10:25 AM (Camp Lakodia)

Minutes from previous meeting were reviewed. Mark will resend google drive access information to Grovenburg. Mark made motion to approve minutes, Grovenburg seconded — motion carried.

Grovenburg provided treasurers report. Board discussed format and amount of detail to be provided in reports. Decision was made to leave amount of detail to the Treasurer. Casey made a motion to accept the report, Travis seconded — motion carried.

Silka provided thank you letters from Dave Steffen and Paul Mammenga for the board to review. Additionally, Silka provided the response of Representative Noem to the Conservation Compliance letter for the board to review. The board also reviewed action on issues that were addressed over email (providing comments on the Bureau of Land management (BLM) Resource Management Plan and draft Environmental Impact Statement (DEIS) and Ft Pierre National Grassland southwest fence relocation and waterline project Environmental Assessment).

No new funding requests were received by board members.

Discussion on emails from current TWS president via budget. Norton commented that this does not really affect us as a state chapter.

Conservation grazing position statement – Pete Bauman sent a position statement on conservation grazing from MN TWS. The board discussed whether we should have a position on conservation grazing. Norton commented that this may be something we should forward to grassland conservation committee as well as the position statement committee. Board will forward to both committees.

The board discussed the use of member email list. What should it be? Disseminate CMPS TWS as well as national TWS information. Other information (such as sharing MNTWS workshop announcement) will be used for newsletter filler.

CMPS meeting. Silka has document to send to board. Active issues (CMPS conservation affairs network):

- Missouri River Confluence Area DEIS – Draft letter was written by Paul Coughlin. Nick's name was spelled inconsistently; Silka will correct and send letter.
- Buffalo Gap land exchange – Letter was forwarded to Public Lands Committee and thought we should respond to it. Will give Lands Committee official go

ahead to respond. Travis inquired if they can do some sort of conservation easement on land being given up. Silka would ask Dennie Mann.

- Nebraska National Forest (NNF) Outfitters and guides – NNF initiated an assessment of need for authorized outfitting or guiding activities. During board discussion, Travis stated that we have sent letters in past in protest to same issues. Present to Public Lands and Fee Hunting and Ownership of wildlife committees. Board consensus was to let them draft letter referencing our position statement.
- Sharing Comment letters
 - BLM comment letter – had a request for a copy of Chapter’s comment letter from SDTWS member. Silka provided a copy.
 - Board also received a request for Chapter’s comment letter from a non-member. This initiated discussion on use of letters. Mark commented that all letters are public record once submitted. Prior to submission we should be more cautious. The Board has no issues sharing published letters. Could even place letters on website. Silka will respond to non-member letter request and have them placed on the website.

Awards Committee – Board discussed upcoming call for professional and citizen awards for 2014.

Travis asked if we should have a position statement on wind energy. Possible limited involvement by USFWS-employed members? Maybe have a draft ready for next business meeting to stimulate discussion. Silka will visit with Dr. Kent Jensen.

Mark gave an update on the 14 August NRCS Tech Committee meeting.

Update on conservation compliance. Travis attended town hall meeting with Representative Noem at the SD State Fair. Half of the meeting was non-farm bill related. Noem stated her support for sodsaver. Frank Lucas (House Ag. Chairman) was against linking compliance to crop insurance.

2014 meeting theme and banquet speaker. The board talked about guest speaker requests and costs. Mark proposed the theme of educating the larger public on conservation work beyond the tip of a fishing pole or barrel of gun. Focus on different ways of generating funding and awareness. Focus more on general public and not just hunters and anglers. Mark will do the meeting agenda.

No additional business.

Grovenburg made motion to adjourn. Casey seconded. Silka adjourned at 11:50 AM.

South Dakota Ag Conservation Coalition Luncheon

In September 2012, in the midst of all the work that was going on at the national and local levels to include satisfactory wildlife and natural resource provisions in the Farm Bill, the Theodore Roosevelt Conservation Partnership (TRCP) offered a way to more efficiently coordinate South Dakota conservation organization efforts in the political process. Collectively, the TRCP helped to form the South Dakota Agriculture Conservation Coalition. The Coalition is now composed of every conservation organization operating in South Dakota, several businesses, landowners, agriculture interests and individuals. The Coalition has been instrumental in producing and circulating conservation issue briefings, reports, sign-on letters, news articles and action alerts for such major concerns as; Sod-saver, Land & Water Conservation Fund (LWCF), Crop Insurance/Conservation Compliance, water quality issues,

wetland draining, grassland conversion and partnership proposals. The Coalition has met directly with Senators Johnson and Thune and with Representative Noem on a number of these issues and coordinated Congressional field visits to SD, while carrying the messages on conservation for the membership.

The Coalition is interested in strengthening its grassroots constituency and making sure that we are working on the priority things that matter in South Dakota. To that end, we are inviting all participants in the upcoming South Dakota Chapter of The Wildlife Society annual meeting on February 24th, 25th and 26th at Cedar Shores Resort in Oacoma, SD to join us for a free luncheon on Feb. 26th at the Resort from 12:30 PM until 2:00 PM. Wildlife Diseases Committee

Chronic Wasting Disease (CWD): From July 1, 2013 to January 15, 2014 a total of 169 samples (122 elk, 8 mule deer, and 39 white-tailed deer) were collected from southwestern South Dakota, northeastern South Dakota, and the Black Hills of South Dakota. As of January 15, 2014 all results are in except for 9 pending results, and we have found 7 CWD positive elk, 6 CWD positive white-tailed deer, and 2 CWD positive mule deer. Since testing began in 1997, South Dakota has documented 251 cases of CWD (86 elk and 165 deer) in free ranging deer and elk. Wind Cave National Park accounts for 66 of these animals (56 elk and 10 deer). Custer State Park has found seven elk and one deer. A total of 25,066 wild deer and elk have been tested for CWD since 1997.

We are collecting all elk samples as we have in the past, but only sample deer heads from CWD units that are submitted to the Rapid City Regional Office. We continue to test any suspect animals from across the state.

Epizootic Hemorrhagic Disease: The State of South Dakota experienced another substantial die-off of white-tailed deer during September-October 2013 due to Epizootic Hemorrhagic Disease (EHD) and Blue Tongue (BT). South Dakota started receiving reports of sickly and deceased white-tailed deer during the late summer and early fall, and as in previous years, we suspect EHD, and move towards documentation of the virus through our Diagnostic Lab at South Dakota State University. Through laboratory testing, we confirmed that both the EHDV and BTV virus was present in mainly white-tailed deer, but also confirmed in elk, and pronghorn. South Dakota continued with documentation of sick and dead wildlife until the middle of October when most of the state experienced its first killing frost and thus the end of the biting flies.

Eleven counties from across South Dakota had confirmed EHD virus (14 cases) or Bluetongue virus (11 cases) in white-tailed deer, elk, or pronghorn. Most cases were found in western South Dakota with a total of 678 deer, elk, pronghorn reported. In the eastern side of the state, a total of 169 reports of dead or sick deer were recorded. A total of 847 dead or sickly deer, elk, or pronghorn were recorded in South Dakota during 2013. Totals included 825 deer, 19 pronghorn, and 3 elk.

Pneumonia in Bighorn Sheep: SDGFP has concluding research through SDSU on bighorn sheep and the dissertation is being completed. We continue at a reduced level to monitor bighorn sheep for health issues, and documented 2 lambs with pneumonia again this year. We believe that we continue to loose bighorn lambs to the disease as we have only documented 7 lambs that survived to our fall survey period. We have documented the pneumonia complex in our adult bighorns, and have experienced some adult mortality due to pneumonia. We look forward to the final report and analysis.

Tuberculosis: Bovine TB was found in a cow from the Hutchinson/Turner County area in late 2013. The Animal industry board is testing other cattle herds in the area and we are waiting for some results. We continue to work with the State Veterinarian to monitor for the disease in wild cervid populations. Staff knows what to

look for, and we are looking for any abnormalities in harvested cervids to monitor for the disease in our cervid populations. We have not found anything in our deer or elk that would suggest that TB is in the wild cervid populations in any area around these cattle operations.

Other: Diseases that we are aware of and monitoring for in South Dakota include White Nose syndrome in bats, plague in prairie dogs, rabies, and west nile virus. A lot of this monitoring is done through the South Dakota Department of Health, and we work well with the Animal Industry Board on other disease issues.
