  - ACTION ITEM: ?
3. Contribution towards Chapter of the Year Trophy ("Jackaloupe")
  - Requesting that each Chapter contribute \$30
  - ACTION ITEM/DECISION: ?
4. Purchase of Projector, slide advance, and laser pointer for workshop conferences
  - All agreed on need
  - Concerns about where to house the equipment. Suggestion made to keep with the President's box
  - Larry Saslaw motioned to authorize \$500 for equipment purchase. Kris Robison seconded.
  - ACTION ITEM: Have Howard Clark look into pricing.
5. Workshop Updates
  - Southern SJV Plant Workshop (April 8-11): Registration open, closes on Mon. Currently low registration (4). We would break even with 20 people. A big thank you to all whom have assisted.
  - Tracking Workshop: Jim Lowery will be instructor. Tentatively scheduled at Windwolves Preserve from November 14-15, 2015. Would be one day classroom, 1 field day. Will be \$100/person with 12 person minimum. Will possibly combine with camping trip.
  - Urban Ecology Workshop. Lori tried to contact Dr. Katti in Jan, no response. Possibly 2016.
  - Future workshop ideas: BNLL (2016), TCBB (maybe after a few years), CTS, small mammals.
