

Remarks from the President



Happy New Year!!! It is hard to believe that another year has come and gone. It seems like just yesterday that we were wrapping up the third Oklahoma Natural Resources Conference. Last year's conference was another success with a large turnout (269 attendees and 72 presenters) and very diverse and informative presentations that covered the myriad of natural resource topics and issues in the state. I was especially impressed by the number and quality of the student presentations.

This year's conference, which is February 21-23 in Tulsa, is shaping up to be another success. We have 75 submitted abstracts (67 oral and 8 posters) and a plenary session entitled "Human Dimensions in Natural Resources for Collaborative Conservation" scheduled on the opening morning of the conference.

Our goal for the plenary session is to focus on human dimensions in natural resources with an emphasis on highlighting successful partnerships and programs as well provide insight on some of the problems and issues that may hamper them. We have invited 4 outstanding speakers (Mike Sorice, a faculty member from Virginia Tech University who investigates human behavior as it relates to environmental stewardship; Mike Fuhr, state director of Oklahoma TNC; Christian Hagen, science advisor with NRCS who has been involved with the lesser prairie chicken initiative and other initiatives; and Ashley Tanner, who is employed by Western Ecosystems Technology, Inc. as their deputy science director for the Middle Rio Grande Endangered Species Collaborative Program) who will bring a wealth of experience and interesting insights about human dimensions in natural resources. Additionally, we have two interesting symposia entitled "Effective Communications for Natural Resource Professionals" and "Growing Season Burning" scheduled for the afternoon on Wednesday, February 21. I hope that many of you can make it to Tulsa next month for the conference.

Oklahoma Chapter of the Wildlife Society Annual Business Meeting Minutes Oklahoma Natural Resources Conference February 23, 2017 at Hyatt Regency Hotel in Tulsa, OK

President Josh Richardson called the meeting to order at 4:27 PM. Approximately 30 people attended the meeting.

Awards - OKTWS Awards Committee Chairman Craig Davis presented annual OKTWS awards.

- Evan Tanner, Dwayne Elmore, Sam Fuhlendorf, Craig Davis, David Dahlgren and Jeremy Orange received the Publication and Creativity Award for peer-reviewed scientific articles for "Extreme Climatic Events Constrain Use and Survival of a Ground-nesting Bird" published in Global Change Biology. Chairman Craig Davis was not involved in voting for this award.
- Andrew Little, Stephen Webb, Kenneth Gee and Steve Demarais received the Publication and Creativity Award for popular articles for their succession of articles "Vanished" published in Quality Whitetails.
- Michael Porter and Scott McNeill received the Publication and Creativity Award for electronic media for the video "Snakes of Oklahoma" produced by the Samuel Roberts Noble Foundation and available on www.noble.org website.
- Erica Perez received first place in the Student Research Award, which was announced after this meeting at the end of the Oklahoma Natural Resources Conference. First place in the Student Research Award is also known as the Moser Award.

Josh Richardson explained voting for officers will occur via email after conclusion of the Oklahoma Natural Resources Conference. Josh Richardson said new officers will start their positions 30 days after the email vote. Craig Davis is President-elect and will become the next President.

Josh Richardson made a recommendation and after considerable discussion, Rex Umber made a motion to hold a vote via email to change OKTWS Bylaws so Secretary and At-large Board Members would become 2 year-positions while President and President-elect remain 1-year positions. Victoria Jackson seconded the motion and those present unanimously approved the motion. Treasurer was already a 2-year position. If the change is approved through email vote, officer positions will be staggered in the following manner during April 2017 to February 2018: Mike Porter will serve the second year of his 2-year term, Kristen Gillman will serve the first year of her 2-year term, Mike Sams will serve the first year of his 2-year term, and Matthew Fullerton will serve the second year of his 2-year term.

Treasurer Report

Treasurer Michael Sams provided the following report:

January 1, 2016 OKTWS balance was \$21,267.47.

2016 income was \$38,469.98.

2016 expenses were \$39,153.46.

December 31, 2016 balance was \$20,583.99 (includes both OKTWS main account and OKTWS Byron Moser account).

OKTWS main account had \$13,913.73 on February 23, 2017.

OKTWS Byron Moser account had \$4,126.30 on February 23, 2017. The Byron Moser account pays for the first place Student Research Award. Pam Moser donated about \$229 to the Byron Moser account recently.

OKTWS had 62 paid members during 2016.

Previously, Northeastern Oklahoma State University students requested and OKTWS gave them \$600 financial assistance to help defray their participation expenses in the Oklahoma Natural Resources Conference.

Previously, OKTWS paid for drinks and part of lunch during the October 11 Oklahoma Department of Wildlife Conservation and Oklahoma State University Fire, Wildlife, Timber and Cattle Field Tour at Pushmataha Wildlife Management Area. OKTWS co-sponsorship was acknowledged with signage at the event.

Josh Richardson suggested OKTWS consider financial support of some Samuel Roberts Noble Foundation educational events such as White-tailed Deer Management Workshops and Prescribed Burning Field Days when OKTWS co-sponsorship is acknowledged with appropriate signage at the event.

During this meeting, Oklahoma State University Student Chapter of the Wildlife Society requested \$2,000 financial assistance from OKTWS for 10-11 students to participate in the Western Conclave. After considerable discussion, Craig Davis made the motion that OKTWS provide up to \$2,000 for students from the Oklahoma State University Student Chapter of the Wildlife Society and University of Central Oklahoma Student Chapter of the Wildlife Society to participate in the West-



Call for Student Papers for TWS Research Award

This award rewards undergraduate and graduate students who conduct outstanding research in natural resource ecology and management. Subject matter includes topics in range, wildlife, natural resource, and environmental sciences. Please send electronic files to Craig Davis, craig.a.davis@okstate.edu. Contact Craig for more information. Entries are due by **February 2, 2018**. Awards of \$500, \$200 and \$50 and plaques will be given to the top three competitors.

Eligibility

Graduate and undergraduate students are eligible. Students who have graduated since the last OCTWS meeting are eligible if they are members of OCTWS at the time of the annual meeting. Students must be the senior author of the abstract and oral presentation. The work being reported must be primarily that of the student. Research projects should be based on at least one season or year of data collection. Only students who are affiliated with an Oklahoma college or university at the time of research or students who conducted field work in Oklahoma, but are affiliated with an out-of-state college or university, are eligible to compete.

Extended Abstract Submission

The extended abstract must follow the style of The Journal of Wildlife Management (JWM; see example and visit http://onlinelibrary.wiley.com/store/10.1002/(ISSN)1937-2817/asset/homepages/JWMGuidelines2011Final.pdf?v=1&s=2b3c6 97db77509e634f2612b03449ed67b435687 for complete style guidelines). Limit abstract length to 300 words. Abstracts will include 1) a statement of justification for the research; 2) a statement of research objectives or hypotheses tested; 3) brief description of methods; 4) concise presentation of salient findings; and 5) implications of findings. Do not include tables, appendices, or literature cited. Submit abstracts in Microsoft Word as e-mail attachments.

TWS Publication and Creativity Award

Please consider nominating someone for the TWS Publication and Creativity Award presented to member(s) of the Oklahoma Chapter who, as individuals or members of a team, make outstanding contributions to natural resource management and conservation through books, technical articles, popular articles, videos, or other media or programs completed within the last 3 years, including the current year. General criteria to be used for nominations for the Private Land Management Award, the Harold C. Stuart Conservation Excellence Award, and The Oklahoma Award:

- 1. A nominee should live or work in Oklahoma or have done so during period pertinent to the nomination.
- 2. A nominee may have received professional training or be a layman in the field of wildlife management.
- 3. A nominee is not required to be a member of The Wildlife Society or the Oklahoma Chapter.
- 4. A nominee's achievement need not have occurred in the 12 months prior to the date his accomplishments are recognized.

The information for nominations should include:

- 1. Name, title.
- 2. Education place, degree(s).
- 3. Pertinent Employment past and present, place and dates.
- 4. Distinguishing activities (may include papers).
- 5. Reason for which nomination is being made.
- 6. Signature of nominator.


