### Strategy for comments on EIS/EA's:

## Award Winner



### Colorado TWS Travel Grant – Sarah Garza

Wildlife Disease Association International Conference – Tamaya, New Mexico

I arrived in at the International Wildlife Disease Association Conference in Tamaya, New Mexico via a carpooling group. I considered the 7-hour drive to be much more economical compared to flying in and, lo and behold, I think I learned more as well since I was able to discuss current wildlife disease management projects with my fellow riders. After registering myself the first day of the conference, I attended the WDA/WVS Session on Field Techniques to Improve Animal Welfare, moderated by Sonia Hernandez and Anne Justice-Allen. From using drugs to reduce stress in captured animals to evaluating the effectiveness of anesthetics, these lectures provided insights into animal welfare issues in the wildlife disease study disciplines. But even though this first session was fascinating, the jewel of the conference was to be the next day when I attended concurrent sessions on diseases of wild ungulates and marine species. Learning about these fascinating projects from all over the world was an amazing and magical education experience. Right from the start, I was especially interested in methodologies to aid in future wildlife management. For example, I made a special note of new ideas such as targeting the feces of bats from cave floors instead of wall substrates when screening for the destructive White Nose Syndrome fungus.

I also learned a great deal of what exactly entails a career in wildlife disease ecology. For example, a great deal of protocol goes into each project and the logistics of these are of the upmost importance. When discussing epidemiology with Dr. Melissa Miller of the University of California-Davis, she described public outreach as being a very important aspect of any wildlife disease project. When you project involves the public audience, the efficiency of the project increases dramatically, especially if there is a vested interest in the outcome. Armed with this new knowledge, I am more aware of my intended career, both the scientific and communications aspect of it.

The conference also provided an especially unique networking opportunity for me. I met and discussed future projects with so many scientists it was hard to keep track of everyone but I made it a special mission to meet and greet scientists from Massey University in Palmerston North, New Zealand, an educational institute I am considering for a PhD project. I meet a current PhD student and asked her many questions about the university, the locations, the benefits of the programs, and people to contact should I decided to pursue the project. The way we met could not have been better even if I had been planned...we were both stranded under the same umbrella in the rain at a banquet event on the last night of the conference! I think I made my first New Zealand friend at the Wildlife Disease Association Conference and I hope to continue our contact when I do eventually move out there. I am extremely grateful to The Wildlife Society for providing the travel grant which enabled me to attend and allowed all of this to happen.

## **Student Chapter Updates**

### Colorado State University Student Chapter of TWS Update

Although students have been away for summer, members have still been active in TWS activities. In coordination with Colorado Parks and Wildlife, the Chapter established raptor monitoring protocols at Boyd Lake State Park. Since April, students have been going out twice a month to observe birds of prey, their use of the habitat and established nests. Students monitored two successful Great Horned Owl nests, a successful Swanson's nest and made countless sightings of other impressive raptors. The program provides critical data for the Park and opportunities for students to develop their birding skills and proper data collection techniques.
