Dear Chairman Bishop and Ranking Member Grijalva:

On behalf of our 84 respective organizations, we write in support of H.R. 5133, the Federal Land Transaction Facilitation Act Reauthorization of 2018, a critical lands bill for the West that supports local economies, resolves private-public land "checkerboard" issues, and conserves high-priority lands for recreation, wildlife habitat, and historic preservation. We appreciate your leadership on this bill and bringing it to Committee markup today. We urge you to make the enactment of a permanent reauthorization of FLTFA a priority this year, including working to include it on any upcoming larger legislative vehicles.

Originally enacted in 2000 (P.L. 106-248), and expired in 2011, FLTFA is a "modified land exchange" program for Alaska and the eleven contiguous western states. The FLTFA program works under the authority of the Federal Land Policy and Management Act (FLPMA), including its lands sales policy, and makes the change to create a "Federal Land Disposal Account" ("Account") that facilitates Bureau of Land Management (BLM) land sales and federal agency conservation in an efficient and strategic manner. With FLTFA, the proceeds from the sale of BLM lands identified for disposal are directed to the special Account to fund priority conservation projects by the BLM, U.S. Forest Service, National Park Service and U.S. Fish and Wildlife Service that will increase access for recreation, protect rivers and

trails, and preserve historic lands. The FLTFA program resulted in 39 recreational access and conservation projects with willing sellers from 2000-2011, including at Zion National Park in Utah and Elk Springs Area of Critical Environmental Concern in Arizona. The Account also provides some funding for the BLM land sales process. FLTFA helps resolve the “checkerboard” of public and private lands in the west by facilitating land consolidation, which helps counties, ranchers, businesses, and communities meet local needs; increases public access to recreation; protects valuable natural and cultural resources, including critical wildlife habitat; reduces land management costs and risks; and other benefits.

We support permanently reauthorizing FLTFA this year, to reinstate an incredible western lands tool that benefits the environment and the economy. FLTFA cannot be utilized again until it is reauthorized, and we appreciate your work to bring it back for the West.
