- 50<sup>th</sup> Anniversary Logo completed by Robin Phanco. Available in two colors and black and white. Have not yet worked on the list of wildlife viewing areas in Chapter boundaries or sharing CDFW brown bag seminar info (note on latter: these seemed to have ceased at CDFW; will have to check in on these). Renee can do GIS story map once the wildlife locations are identified. ACTION ITEM: Ask Linda Connolly about any outstanding NCC \$ issues.

Ryan Lopez – Treasurer

- We currently have \$33,016.41 in the Chapter bank accounts.

Jeff Davis –Chapter Representative

- Chapter dues should be due in fall/end of calendar year to keep in sync with TWS.
- 2015 Student Conclave at Cal Poly was first one in Western Section. In 2017 will be in Yosemite in the Spring. Jeff will help with field opportunities. Will be at the UC Reserve Center in Wawona.
- Western Section is evaluating 2019 meeting venues. Visalia or Tenaya Lodge being considered, Oakhurst 20 min away from the latter. Could be good for wildlife, and could be a smaller crowd with more outdoor options. All meals would have to be on site.

- Proposals will be sent to Chapter Board, will be approved with majority vote.

1. Courtright Camping Trip Summary: 11 participants, including 5 board members. Aug 5-7, 2016. Was a great time. Will post pictures on Chapter FB site. Will do again next year.

2. Aug/Sept Professional Lunch: CSUF on-board. Contacted Paul Crosbie. Will be at lunch hour. Chapter to provide Pizza and soda, about \$200. Will be 6-7 professionals. ACTION ITEM: Lori will discuss/firm up details soon.
3. CDFW Sponsored workshop on Policy and Implementation: CESA workshop, possibly in Nov or early Dec. Maybe at the Falls Conf Center in Fresno? ACTION ITEM: Julie to look at venues and firm up dates.
