President's Column

Recent events of police brutality and racial discrimination which have been so prominently displayed in our country have made it very clear to me how far we are from the inclusive and equitable society that we strive for, and that we sometimes talk about as if it's already here. I am deeply saddened by this shortcoming. This recent sadness only reflects my own privilege, as I am a cisgender, heterosexual white male - I am not the target of racism or sexism - and I can be complacent even when the discrimination is right in front of me. Perhaps many of us share this implicit bias and need a wakeup call!

Look around at your work, your office or conference table, or at our annual meeting: Do you see full representation? Too often, I do not. Why does the wildlife profession lack diversity in race, sexual orientation, and other backgrounds? And importantly, how does this demographic homogeneity cripple our ability to adapt and thrive in the 21^{st} century? Does our lack of cultural diversity mirror a depauperate ecosystem that lacks biodiversity and fails to thrive? Perhaps this homogeneity also further harms the people who don't feel included – I find a meaningful, personal connection to wildlife and wilderness but fear that many people don't feel welcome in our community and never get a chance at that connection.

So, where do we begin? Each one of us must strive to welcome all diversity. I truly believe that personal efforts to welcome and respect all those present will lead to new member diversity. I see many women around me in the wildlife community, but I'm afraid that we have not done as well with people of color or gender diversity (and I'm not certain that the women present never suffer sexual discrimination). I'm asking each one of you to take some action to further this cause.



Work hard on a personal level to uphold the official TWS Position Statement on Workforce Diversity in the Wildlife Profession: "The Wildlife Society recognizes the value of including the richness of human diversity in our efforts to discover, educate, inform policy, and involve the public in wildlife science and management."

The board of the TWS - Colorado chapter is currently actively engaged in this conversation. I am committed as your chapter president to drive this conversation, and engage in the long, slow process of positive change. I do not yet know what the outcome of that work will be, but we will continue to share news with our members as we make progress.


As long as I am a member of this board, I will continue to work to ensure that this chapter welcomes all and respects all. Please join me in this cause.

The Colorado Chapter of The Wildlife Society is partnering with RiversEdge West for our annual conference in 2021, which will be hosted at the Hutchins Water Center at Colorado Mesa University. This annual meeting will explore ways in which river restoration impacts people, wildlife, and habitat for native species. We invite you to present a symposia, panel discussion, oral presentation (traditional format) or poster on the topics of wildlife research, ecology, management, conservation, education, or policy at the 2020 annual meeting of the Colorado Chapter of The Wildlife Society.

Our plenary session will focus on novel, timely, and interesting research or case studies that would be of interest to a broad range of managers, scientists,

conservationists, and citizens who are working to bring back damaged riparian areas. We will highlight incorporate lessons learned, impacts to wildlife, climate change/adaptation, innovative approaches, applied science, best management practices, and/or analyses of riparian or stream restoration.

For the traditional oral presentations, all topics are welcome, and we strongly encourage students to present. All student presentations will be considered for the "best presentation" and "best poster" awards, which include a gift certificate and recognition at the end of the conference.







Call For Abstracts

Presentations, Posters, and IGNITE The Colorado Chapter of The Wildlife Society Annual Meeting: February 16th - 19th, 2021 Grand Junction, Colorado

Symposia: Symposia are comprised of a series of presentations that address aspects of a single topic. Organizers can request sessions that are 5 or 10 talks in duration. Each talk is 20-minutes. Symposia may include panel discussions as part of their session. Symposia are scheduled to run concurrently with other conference sessions. Attendance is open to all conference registrants. You may suggest your preferred format (e.g. multiple presentations surrounding a specific theme, panel discussion, workshop) for symposia/session structure.

Panel discussions: Panel discussions are a forum for interactive discussion of a topic among a panel of experts and an interested audience. Typically, a panel of four to eight speakers makes introductory remarks. The audience is then invited to make comments and question the panel. Panel discussions are scheduled for 100 minutes and will run concurrently with other conference sessions. Attendance is open to all conference registrants.

Traditional oral presentations: 20 minutes allotted for each presentation (15-18 minutes for presentations followed by 2-5 minutes for questions and answers). Oral presentations are limited to Microsoft PowerPoint or Adobe PDFs. No other formats will be accepted. Presentations must be uploaded at the beginning of the session in which you will present.

Poster presentations: maximum dimensions are 4 feet by 4 feet in size. Easels will be provided. At this year's conference, we will schedule a formal poster session before the banquet, allowing presenters more time to discuss their work with conference participants. Attendance at the poster session is required for presenters, and will be on Wednesday, February 17th from 5-7 pm. The abstract deadline for poster presentations is January 15, 2021.

IGNITE presentations: These "To the Point" sessions have been an exciting new staple in recent conferences, and provide a great platform for members to quickly share updates and information that don't require a full 20-minute presentation. Ignite-style talks include automated slide progression condensing the talk to 5 minutes! Talks can be funny, inspirational, or informative, but should all strive to be engaging and entertaining. Please see additional formatting information below if you are interested in an IGNITE presentation.

Abstract submission deadline: October 16, 2020 for IGNITE and traditional oral presentations; January 15 for poster presentations.





The Colorado Chapter of the Wildlife Society is now accepting applications for its Fall Travel Grant Program. The purpose of the CCTWS Travel Grants Program is to assist with travel costs for CCTWS members attending meetings or workshops that further their professional knowledge and benefit management and conservation of wildlife in Colorado. CCTWS will award one travel grant in the amount of \$500. The applications guidelines are as follows:

- Identify the training opportunity, meeting, or conference that would be helpful for your occupation or education as a wildlife professional or student CCTWS member.
- Type up a ½ to 1-page description of the meeting, telling the CCTWS Board the goals of the conference or training and describing how you would like to use this experience for your occupation or education. Be sure to explain how this meeting would be a valuable contribution to your employment or education as a Wildlife Professional.
- Include your name and contact information (phone number and email).
- Only current members of the Colorado Chapter of the Wildlife Society are eligible for these grants.
- Applications for Fall Travel grants are due by **August 1.** Winners will be notified by **August 15th**.

Treasurer's Report

CCTWS Treasurer's Report

As of June 29th

Checking account - \$13,594.83

- 2019 CSU-Pueblo Chapter sponsorship \$1,200 (check has been sent, but not withdrawn)
- \$2,000.00 will be transferred to Scholarship Fund/Investment (\$750 from 2019 budget line item and \$1250 from donations (\$500~Robin Olterman, \$500~John Seidel, \$250~Gene Byrne))
 - Reserve Fund Money Market \$35,228.47
 - ∘ Savings Account \$508.83
 - CCTWS Target Reserve for 2020 \$36,487.67 (Reserve Fund and Savings account)

The CCTWS board has approved a 2020-21 operating budget of \$7,985 during the May meeting. Expenses for 2020-21 include board operational funds (\$1,000), two small research/education grants (\$750 each), two travel grants (\$500 each), CSU student chapter (\$1,200), Western Colorado University student chapter (\$1,200), CSU – Pueblo student chapter (\$1,200), two reimbursements for TWS wildlife biologist certification (\$155 each), and CMPS membership dues (\$575). The operating budget does not include costs associated with hosting the annual meeting.
