## Take Action!

**Recovering America's Wildlife Act introduced to U.S. Senate** – TWS members and units have a new opportunity to build up support for the Recovering America's Wildlife Act thanks to the recent [introduction](#) of a Senate companion bill ([S. 2372](#)). The bill, introduced in late July by Senators Martin Heinrich (D-NM) and Roy Blunt (R-MO), would provide much-needed funds to state, territory, and tribal governments to work on at-risk species conservation efforts. **Migratory Bird Protection Act introduced to U.S. House** – Legislation that would strengthen protections for migratory bird species under the century-old Migratory Bird Treaty Act has been reintroduced to the U.S. House of Representatives by Representatives Lowenthal (D-CA), Fitzpatrick (R-PA), and dozens of their congressional colleagues. Members can learn more about the Migratory Bird Protection Act ([H.R. 4833](#)) and its goal of codifying take protections for MBTA-listed species through TWS' [Action Center](#). **Position Announcement: Conservation Affairs Network Fellow** – The Wildlife Society is hiring a [full-time, term-limited Conservation Affairs Network Fellow](#) to support the work of the network. **AFS seeking member input on instream water conservation center** – Our partners at the American Fisheries Society are requesting member input of the feasibility of establishing a national U.S. center dedicated to training and support services for

instream flow and water level conservation studies. For nearly two decades, instream flow conservation principles were provided under the direction of the federal Cooperative Instream Flow Service Group (CIFSG) in Fort Collins, Colorado. Since that group ceased to exist in 2001, no substitute centralized source of training and support services has been established. AFS requests that interested members and parties fill out a [questionnaire](#) to help assess the needs and support for a new National Center no later than August 6. The survey should take approximately 10 minutes to complete.

**North Dakota Chapter provides testimony on Outdoor Heritage Fund** – The [North Dakota Chapter of The Wildlife Society](#) provided two testimonies in March. The first was regarding [HB 1009](#), the Agriculture Commissioners budget, which was amended to include a \$200,000 appropriation from the Outdoor Heritage Fund (OHF) for defraying the expenses of the soil health cover crop grant program. The Chapter strongly opposed this amendment, and urged its removal. The second was [joint testimony](#) that the Chapter signed, alongside several other organizations in the state, to express their concerns regarding [HB 1215](#), which would direct portions of the Outdoor Heritage Fund to the Bank of North Dakota to provide for a loan program. *CAC Contact:* [Jesse Beckers](#)

## Federal Updates

**Recovering America's Wildlife Act gains momentum in U.S. House** – Alongside Senate introduction, recent House action on the Recovering America's Wildlife Act ([H.R. 2773](#)) has kept the legislation top of mind for lawmakers. Last week the House Natural Resources Water, Oceans, and Wildlife Subcommittee held a hearing on the Recovering America's Wildlife Act and several other measures targeting the biodiversity crisis. A recording of the hearing can be found on the [committee's website](#). The House bill also reached [100 cosponsors](#) last week, thanks in large part to efforts from TWS units and partners. **MBTA economic analysis open for public comment** – The U.S. Fish and Wildlife Service has opened a [comment period](#) on two economic analysis documents prepared during development of a [May 2021 proposed rule](#) that would revoke a [January 2021 rule](#) excluding the regulation of incidental take under the [Migratory Bird Treaty Act](#). Comments are due August 19. TWS is coordinating with other conservation organizations on review of the documents to determine any comments that may be warranted. **U.S. House moves on FY 2022 funding** – Last week, the U.S. House of Representatives passed a “minibus” Fiscal Year 2022 spending package that included several of the [12 funding bills](#) Congress needs to send to the President’s desk before FY 2021 wraps at the end of September. Within this [package](#) were several funding increases for federal conservation programming, including programs like the U.S. Geological Survey’s Cooperative Research Units program (+\$2 million) and [North American Wetlands Conservation Act](#) grants (+\$3.5 million). While not yet law, the House package will serve as a negotiating tool when the U.S. Senate decides to take up FY 2022 spending. As of late, the Senate has largely been consumed with negotiations over a \$1 trillion bipartisan infrastructure package. No movement on Senate FY 2022 funding proposals is expected until after the August recess.
