The North Carolina Chapter of the Wildlife Society (NCTWS) is **requesting your support** for the House bill titled “**Migratory Bird Protection Act of 2021**” (H.R. 4833). This bill was introduced by the House of Representatives on 29 July 2021. In summary, H.R. 4833 prohibits incidental take of migratory birds by commercial activities unless it is permitted by the USFWS or identified as posing de minimis risk to migratory birds. Additionally, the bill stipulates that the USFWS will establish and maintain a research program to evaluate the impacts of commercial activities on birds to improve and develop new best management practices and technologies to avoid or minimize impacts. Currently, there are 78 cosponsors of the **bipartisan** House act including North Carolina Representative Ross.
