Thank you to all TWS units and members for your support of the Recovering America's Wildlife Act – Although the [Recovering America's Wildlife Act \(H.R. 2773/S. 2372\)](#) was ultimately [left out of the omnibus spending bill at the end of 2022](#), it is important to recognize the time and effort that TWS members and units dedicated to supporting this legislation throughout the last year in the form of meetings, phone calls, emails, and formal letters of support to their members of Congress. It is thanks to these efforts that the bill was able to progress so far during the last Congress. Federal Updates

TWS submits comments on bald and golden eagle permitting – In conjunction with the [Renewable Energy Working Group](#), The Wildlife Society recently submitted [comments](#) on proposed [rule changes](#) to the implementation of permitting under the [Bald and Golden Eagle Protection Act](#). The proposal aims to increase participation in the permitting process by creating a general permitting program for activities such as wind energy development and power line

operations. As part of the comments, TWS suggested the drafting of guidance that considers additional appropriate mitigation activities, particularly for at-risk golden eagle populations. TWS also suggested a standard operating procedure for preference in data set utilization that incorporates state, tribal, and local data. *Staff contact:* [Caroline Murphy](#)

Congress approves FY 2023 Appropriations – In late December Congress passed the FY 2023 appropriations package, which includes funding levels for the Department of Agriculture and Interior. Under the bill, programs advocated for by TWS saw [minor increases](#). The U.S. Fish and Wildlife Service received \$73.8 million for the implementation of the [State and Tribal Wildlife Grants Program](#), \$2 million above FY 2022 levels. Meanwhile, the [National Wildlife Refuge System](#) saw a minimal increase of \$22 million, totaling \$541.6 million. The U.S. Geological Survey received \$28 million for its Cooperative Research Units program and \$83 million for the Climate Adaptation Sciences Centers. *Staff contact:* [Caroline Murphy](#)

Biden administration finalizes WOTUS rule – The Environmental Protection Agency and the Army Corps of Engineers announced in December a [final rule](#) providing a new definition for “[Waters of the United States](#)”. A revision to the Clean Water Act, the definition resembles one used pre-2015 with updates to reflect recent Supreme Court decisions and updated science. The rulemaking grants federal protections to large waterways, such as lakes, rivers, and streams as well as the wetlands adjacent to them. *Staff contact:* [Caroline Murphy](#)

Updates from Headquarters

TWS endorses grasslands conservation effort – The Wildlife Society recently [joined](#) partners in endorsing the [North American Grasslands Conservation Act](#), legislation introduced last Congress that seeks to establish a North American grasslands conservation strategy for protecting and restoring threatened grassland and sagebrush ecosystems. A grant program would support the management efforts needed for this restoration by funding projects to improve and restore grasslands, support habitat connectivity and enhance biodiversity.
