Board Nomination Requirements:

All elected board members must be a member of TWS parent society. If they are not a regular state chapter member of one of our 7 states (CO, WY, UT, SD, ND, NE, KS), they must be a regular CMPS member for \$1 (state chapter members are automatically enrolled as members of CMPS).

Position Descriptions

ALL POSITIONS: Time commitments include a monthly 1-hour virtual board meeting. Serving on special committees and helping with CMPS Annual Business Meeting (held in conjunction with one of the 7 state's annual conference) will take more commitment. Travel to one of the 7 states' conferences is elective but encouraged. Elected board members will start their term August 31, 2024 and will hold their position for 2 years following.

VICE-PRESIDENT. The Vice-President shall assume the duties of President during any absence or upon any inability of the President to serve and shall perform any duties assigned by the President. This office shall preside over the Awards Committee. In the event the Vice-President cannot serve in the President's absence, the Executive Board shall appoint a President, pro tempore.

MEMBERS-AT-LARGE. Members-At-large assist in general administration of Section business affairs as delegated by the President and serve on committees such as awards, membership/communications, and elections.

We arrived at Louisville at night November 4th and were staying at a hotel not far from The Galt. The next day we spent our time exploring. I took this opportunity to have lunch with some PhD students from the Koprowski Conservation Research Laboratory. I have been working for the lab for about a year now, assisting on tasks with their research projects.

The day when lecture sessions started, I first went to the Communicating in an Era of Science Mistrust. After I attended the Aldo Leopold Address I went to a specific talk about how uninteresting bird get studied less than their fancy counterparts.

On Tuesday me and the secretary went to the student chapter leaders breakfast and had a wonderful discussion with the Texas student chapter. After that I went to talks mostly about international conservations before I went to the pharmacy. In the late afternoon I went to a talk about human dimensions and the conflicts with wildlife.

Wednesday I help set up and attended the Wyoming reception that evening. I had a wonderful time talking to Rich Guenzel and John Koprowski. Me and John had set up a silent auction table with prizes I had collected prior to the conference. We had a great turnout, where we sold shirts and had received donations from many alumni. It was a great night to network and form new friendships and I was excited since this was my second alumni and friends event.

The final day I spent the whole time attending talks. With the majority being from the endangered species panel along with the conservation and invasive species panel.

A wide range of scientists, conservationists, and practitioners from around the U.S. gathered at the 2023 TWS Wildlife Conference to discuss the most recent developments in wildlife management, research, and conservation. The conference offered a forum for idea sharing and encouraged teamwork and creativity in tackling the urgent problems that threaten the biodiversity of our world.

I attended the Agent-based modeling for wildlife management Symposium and one presentation that stood out was the presentation of estimating the potential drivers of dispersal outcomes for juvenile gopher frogs. The presenter explained that individuals may be able to behaviorally regulate their body temperatures and rates of water loss by moving between microsites. This can have significant effects on growth, fecundity, survival, and activity periods. Microclimate variability and availability can be altered by ground-layer vegetation. When thinking about climate, most people including myself would think on a macroscale and not microscale.

The 2023 TWS Wildlife Conference stands as a testament to the dedication of the scientific community in advancing the field of wildlife science and conservation. Through encouraging teamwork, exchanging expertise, and investigating creative solutions, attendees departed the conference with a revitalized mission and resolve to protect the planet's biodiversity. The knowledge from this meeting will be useful as we navigate the difficulties of the Anthropocene and work toward a sustainable and peaceful cohabitation with wildlife.

Mackenzie Smith



The conference began with plenary talks, which highlighted the importance of science communication in a period of misinformation. I found these talks especially relevant in our digital age. In November, I had the incredible opportunity to close out my graduate career by representing North Dakota State University at the 30th annual Wildlife Society conference in Louisville, KY. After presenting at TWS 2022 in Spokane, WA, I was excited to once again return to the national conference for another week of conference fun.

Thanks to support from the TWS Drone Working Group, I started the conference out on a remarkable note, attending the "Taking to the Skies: Drone Applications" Workshop.

These past three years, my Master's research has explored the use of drones in the human-wildlife conflict realm, spe-

cifically the conflict that exists between North Dakota sunflower producers and the large aggregations of mixed-species blackbird flocks that damage the crop. Through this research, I have developed a passion for piloting drones, and I was excited to learn about the vast applications drones have in the field of wildlife biology. With projects encompassing the globe – Sunda Pangolins in Vietnam to Mule deer in Montana – I had the opportunity to hear about the exciting research and innovative tools being used to learn more about the world's wildlife. From the demonstrations of Wildlife Drone's cutting-edge drone-based telemetry system to Canebrake's thermal camera, the workshop went above and beyond, exceeding my expectations.

On the third day of the conference, I had the opportunity to share my contribution to the drone research world during the Contributed and Research in Progress Poster session. I presented a poster, titled "Know Thy Enemy: Using Drones to Evaluate Composition and Size of Blackbird Flocks Foraging in Commercial Sunflower." This project aimed to achieve three objectives: compare biologist flock size estimates to automated methods, 2) develop a machine-learning algorithm to detect and count blackbirds and 3) understand the seasonal phenology of composition of mixed-species blackbird flocks. During the poster session, I had the opportunity to discuss my research with a wide variety of people, from curious under-




Figure 2: Jessica Duttenhefner standing in front of her poster during the Contributed and Research in Progress Poster session.

graduates to Wildlife Services and drone pilot professionals to fellow graduate students. We discussed the difficulties in developing A.I.-based detection models and making field-based flock size and composition estimates, and those who stopped by even had a chance to try their hand at making photo-based flock estimates. I had a fantastic time discussing the ever-expanding role of drones in the wildlife world and envisioning the potential implications of integrating A.I. into wildlife monitoring.

The remaining days were filled with student and professional talks. Provided with a wide variety of symposium topics, I had the opportunity to listen to a diverse selection of research topics – from the talks on songbirds, wading birds, and waterfowl in the Conservation and Ecology of Birds to the applications of drones and machine learning in the New Technology and Applications symposium. The inspiring and impressive research presented in the Women at Work symposium and the thought-provoking and informative presentations in the Public Engagement, Education, and Communication symposium, had me thinking about my future as a woman in the wildlife profession, and how I can use what I learned to best engage the public and communicate effectively with those within and outside of my field in my future career. I attended the Drone Working group meeting, which served as a comfortable, relaxed setting for researchers and professionals to discuss challenges they have faced in drone research and to brainstorm potential solutions. One of my future goals is

to land a career that allows me to combine my passion for wild-life conservation and drone piloting, so to be a part of a collaborative, diverse group of students, professionals and retirees from universities, state, federal, and private agencies is very worthwhile.

My experience at TWS 2023 was overwhelmingly positive, and I would like to use this opportunity to thank the TWS Central Mountain Plains section, TWS Drone Working group, and NDSU Environmental and Conservation Science program for supporting my attendance. Being a part of such a large, international conference has been very rewarding, and the experiences I have had these past two years will not soon be forgotten.

Chapter Updates

North Dakota

The North Dakota Chapter of The Wildlife Society held its Annual Meeting February 6-9, 2024, in Mandan, ND. The theme for this year's Annual meeting was "Heroes, Villains, and Victims; The Human Dimension of Wildlife Management". The meeting was well attended with well over 250 people in attendance. The meeting began on Tuesday afternoon with a Grass Planning Workshop. The purpose of the Workshop was to identify and discuss challenges and barriers facing land managers when restoring grasslands. The Workshop focused on planning and objectives of restorations as well as future management of restored grasslands. On Wednesday evening February 7, the Chapter held its annual fund-raising dinner and event. Raffles, Games, a Live Auction, and a Silent Auction were conducted and resulted in \$10,519.24 income for the Chapter.

Presentations sessions were conducted on Wednesday afternoon and Friday morning. A Student Presentations session was held on Thursday afternoon. A session to view Posters and meet with Poster authors also occurred on Thursday afternoon. Two panels; one on Wetlands and one on Early Career Outlooks were conducted on Friday morning. Also on Friday morning Jill Shaffer of Northern Prairie Wildlife Research Center presented information from her trip last fall to Kazakhstan entitled, "International Diplomacy Through Scientific Exchange of Wind-Energy Effects and Mitigation - Embassy Science Fellowship with the U.S. Embassy in Kazakhstan". On Thursday morning the Chapter conducted its Annual Business Meeting that included the election of a President-Elect and two new Executive Board members and approval of the 2024 Chapter Budget. Phil Mastrangelo transitioned from President-Elect to President and Dr. Bob Newman is now Past President of the Chapter. Curt Francis, North Dakota Game and Fish Department, was elected as the president-Elect and Dr. Torre Hovick, North Dakota State University, and Levi Jacobson, North Dakota Game and Fish Department were elected as new Executive Board members.

CMPS and State Chapter Representation Meeting Minutes, January 31, 2024

PURPOSE: Discuss a proposal to have a voting Representative from each of the 7 TWS State Chapters on the CMPS of TWS Board.

Attendees: Stephanie Ferrero, Elli Teige, Embere Hall, Mel Nenneman, Anna Ortega, Heidi Plank, Rick Warhurst, Riley Bernard, Robin Russell, Erin Considine, Kent Fricke, Matt Gruntorad, Brady Neiles, Dennie Mann, Phil Mastrangelo, Jason Keitchuck, Sarah Nevison, Makeda Hanson (Trujillo?)

At this meeting, CMPS President Stephanie Ferrero presented (Proposed CMPS Board Restructure.pptx - Google Slides) a proposal to change the CMPS Board structure to include one elected board member from each state in the Central Mountains and Plains Section of TWS. The purpose of this proposed change is to provide consistent voting representation for each State Chapter within the Central Mountains and Plains Section of The Wildlife Society.

The following notes include suggestions, comments, and questions (answers when provided) from the conversation following the presentation.

For the Proposed board structure slide, it should be made clearer what the positions are and how many voting members will be on the board.

Proposed structure (n=11): President-elect, President, Past President, Treasurer, State Reps - one each from ND, SD, NE, KS, WY, CO, and UT. Representative to TWS Council (non-voting?)

President-elect serves one year in that office, then proceeds to President for 1 year, then to Past President for 1 year (3-year term)

All other officers (Treasurer, CMPS Representative to TWS Council (?), and State reps) serve 2-year terms.

President-elect will serve on the Nomination/Elections committee.

President will head the committee for Mission and Strategic Plan.

Past President will head the Awards committee.

CMPS Representative to TWS Council serves as the liaison between CMPS and TWS Council.

Treasurer is responsible for tracking and reporting CMPS income and expenditures to the CMPS Board, and developing an annual budget

State Chapter Representatives to the CMPS Board will be tasked with filling the following roles/committee chairs for CMPS: Secretary, Annual Meeting Planning, Membership, Resolutions and Statements/CAN Representative, Publicity, Student and Early Career Professional, and Audit.

CMPS and State Chapter Representation Meeting Minutes, January 31, 2024

In odd years, elect State representatives from Kansas, Utah, and North Dakota, and Treasurer

Note that this is a change from the presentations, as attendees from KS and UT indicated that electing their State reps would work better in odd years as it matches their election cycle, and the office of treasurer was added in odd years so that there would be 4 elected positions in even and odd years (5 elected positions every year as a new President-elect is selected every year)

State Representatives to the CMPS board should be elected in the 1st or 2nd quarter of the year to assume office on the CMPS board on 01 July.

Feedback and comments:

- would be nice if all the elections and award nomination time frames were similar or the same
- -Q does the proposed board structure replace the current liaisons, or did the liaisons not work out? A-The proposed board structure makes the liaisons more formal and hopefully more sustainable.
- Suggestion that state chapters be allowed to add the responsibility of State Rep to CMPS to an existing board position so that the states don't have to change existing bylaws to add the position of State Rep to CMPS. Another chimed in that they liked the idea of having an existing board member serve on the CMPS board. The proposed change to the CMPS board structure provides this as an option to State Chapters (State chapters can decide if they would like to add Chapter Representative to CMPS to an existing board position, or if they would like to create a stand-alone elected position).
- Have observed a disconnect between State Chapters and CMPS, very supportive of this change so that each state has representation (and hopefully better connection with) on the CMPS board.
- Is this potentially limiting for someone that wants to serve on the Section board versus serving at the State Chapter level; might remove an opportunity to serve as the proposed positions have the potential to make serving on the CMPS board a dual function state/section position.
- What is the time commitment for CMPS board positions? What can we tell membership about how much time to expect to put into a CMPS board position if they run for these offices?

A- currently the board meets for 1 hour each month as a board, but this can be adjusted based on schedules of elected board members. Could streamline by planning meetings to focus on deadlines and tasks that need to be accomplished.

CMPS Board Meeting 12 December 2023, 9:00-10:00 am CT (8:00-9:00 am MT)

Meeting called to order by Stephanie Ferrero at 9:07 am CT/8:07 am MT

Attendees: Stephanie Ferrero, Embere Hall, Elli Teige, Rick Warhurst, Mel Nenneman, Dennie Mann, Andrea Orabona, Anna Ortega

With a couple of new folks attending the meeting this month, we took a few minutes to allow everyone to introduce themselves.

State Chapter Liaisons and Representative Updates:

No updates were made at this board meeting. Dennie Mann (SD) said that they are working on getting some speakers lined up for the CMPS/SD annual meeting in March. He has reached out to the Y-to-Y folks but hasn't heard back from them yet. They have gotten about \$2500 in grants for the meeting and hopes to double this amount. Expects meeting will cost ~\$15,000, so would like to have grants and donations to cover about 1/3rd of the cost. Hotel costs are a very reasonable \$72/night.

Old Business:

Meeting minutes from the 14 November 2023 board meeting were shared with the board via Google drive, and the board voted to approve the minutes via email.

Treasurer's report: Mel reported that since the Nov board meeting, CMPS has received membership dues from all the states in our section, and that we are starting to distribute the funds allocated for the Wayne Sandfort student travel grants. Only one student has submitted a report to complete the requirements for receiving the grant. The current CMPS balance is \$8,182.48; the balance available after we fulfill all the Wayne Sandfort student travel grants plus maintaining the \$2500 minimum account balance is \$3,952.48. There were a few board members that could not attend the meeting, so a motion to approve the Treasurer's report will be conducted via email.

New Business:

Anna Ortega has been nominated to serve as the CMPS Vice President. Pending Anna's acceptance of this nomination and approval of the board, Anna will fill the role of CMPS VP!

Corporation Service Company (CSC) is now serving as the Registered Agent for CMPS. Registered Agents ensure that we maintain our status as an incorporated non-profit organization. CSC replaces Colorado Registered Agents as our registered agent. TWS is paying CSC for the first year of service; CMPS will need to budget \$150-200/year starting in 2024 to maintain this service. Action: Mel will add this expenditure to the 2024 budget. In addition, check into the address CMPS uses for a permanent address. CMPS address at Novo bank is Dani Neumann's work address.

Strategic Plan items:

PayPal account – Elli set up a CMPS account that we can use to accept payments for workshops, auction items, etc. Action: Mel set up access to PayPal as treasurer, and link PayPal to Novo account for payments.

CMPS Awards: Formal announcement seeking nominations for CMPS Awards will be sent out in January. Award nominations close 45 days before the annual meeting, so still have some time to accept nominations. If CMPS has nominees for TWS Group Achievement, Distinguished Service, or TWS Fellow, please let Andrea Orabona know. Action: Embere will send out announcement seeking nominees in January.

The TWS Leadership Institute will be seeking TWS members for the next leadership class soon. If this announcement coincides with the timing of the awards nominations, this announcement can go out with the call for awards nominations. Action: Embere – check timing of Leadership Institute application window to see if these announce-

ments to CMPS membership can be combined.

Bylaws and restructuring the CMPS board – had a couple of meetings with CMPS board regarding restructuring the CMPS board the week of Dec 4th. Lots of good input from board members. We will need to meet again in January to continue working on Bylaws review to have ready by the Annual meeting. Action: Stephanie and board- continue to work on bylaws review

Elections committee: Still need some volunteers to assist Heidi with CMPS elections. Any CMPS member can serve on this committee. Committee find candidates to run for CMPS board positions and run the election (have candidates provide bios, post on website/newsletter, Survey Monkey for voting). Action: All board members – seek additional committee members, ask someone you know to volunteer!

Newsletter: Aleshia and others are in the process of putting together the newsletter and hope to have it ready to release on Dec 22rd.

DEI committee- Action: Stephanie will continue reaching out to Bob Newman for any updates on activity. Annual Meeting- Stephanie asked if CMPS could provide a workshop(s) at the annual meeting. At recent annual meetings, CMPS has gotten Dave Haukos (who sits on the TWS Certification Review Board) to provide a well-attended Certification Workshop. Action: Elli will ask Dave if he can provide this workshop at the Annual meeting.

Annual Meeting Fundraising- Rick has been talking to the NDTWS chapter about ways to improve fundraising for CMPS. One possibility is to hold a gun raffle, another is to ask each state chapter to send/designate/donate an auction item for CMPS. Action: Chapter liaisons ask chapter boards for an auction item to donate to CMPS. CMPS board members encouraged to ask businesses that sell outdoor gear to donate to CMPS. An outreach document (Wildlife Stewardship Opportunity Letter Template.docx) has been shared in CMPS Google documents to help with reaching out to potential corporate donors. Action: All – seek at least one auction item from each state in the section for the auction at the annual meeting.

Annual Meeting Quiz Bowl- Check with SD/CMPS planning committee to see if a quiz bowl fits into the schedule somewhere. Andrea indicated that she could help with questions that are tailored to SD as the host chapter, and that this quiz bowl is more laid back than the TWS quiz bowl.

Now that CMPS is incorporated, it might be a good idea to investigate having a formal audit of CMPS finances completed by an outside entity. This outside audit would occur once each year, about a month before the Annual meeting the results would be available to present to members. Stephanie has reached out to several state chapters and Cameron Kovash (TWS) for suggestions on contacting an independent auditor. Concern expressed about the potential cost of hiring an auditor. Suggested that might be able to find a local CPA that could provide this service at a low cost or possibly even waive the fee as a donation. Action: continue to research possible auditors and cost. Rick will ask what organization does the audit for ND.

The January board meeting will focus on budget. Action: Mel will work on having a draft proposed budget for the next meeting.

Other items for next meeting – continue independent audit discussion, annual meeting planning, permanent address for CMPS, monthly meeting time for CMPS board meetings in 2024 (what works for most members).

Stephanie moved to adjourn the meeting, Elli 2nd; motion carries. Meeting adjourned at 10:01 am CT/9:01 am MT

Proposed structure allows states to decide if they would like to elect their CMPS board representative as a standalone position or have this be one of the duties assumed by a current elected board position. States can also opt to have CMPS run the election for this position. Daly moved to approve the proposed restructuring of the CMPS board, Elli seconded the motion, and the motion passed by voice vote. Action: Stephanie & board - State chapters responding by 16 Feb to the proposed changes with their comments and concerns. Collate these responses and continue working on bylaws.

State Chapter liaisons and representative's updates

North Dakota – Rick Warhurst: The North Dakota Chapter of The Wildlife Society held its Annual Meeting February 6-9, 2024, in Mandan, ND, with a theme of "Heroes, Villains, and Victims; The Human Dimension of Wildlife Management". There were over 250 people in attendance. The meeting began Tuesday afternoon with a Grass Planning Workshop to identify and discuss challenges and barriers facing land managers when restoring grasslands. The Workshop focused on planning and objectives of restorations as well as future management of restored grasslands. On Wednesday evening, the Chapter held its annual fund-raising dinner and event. Raffles, Games, a Live Auction, and a Silent Auction were conducted and resulted in \$10,519.24 income for the Chapter.

Presentations sessions were conducted on Wednesday afternoon and Friday morning. A Student Presentations session was held on Thursday afternoon. A session to view Posters and meet with Poster authors also occurred on Thursday afternoon. Two panels; one on Wetlands and one on Early Career Outlooks were conducted on Friday morning. Also on Friday morning Jill Shaffer of Northern Prairie Wildlife Research Center presented "International Diplomacy Through Scientific Exchange of Wind-Energy Effects and Mitigation - Embassy Science Fellowship with the U.S. Embassy in Kazakhstan". On Thursday morning the Chapter conducted its Annual Business Meeting that included the election of a President-Elect and two new Executive Board members and approval of the 2024 Chapter Budget. Phil Mastrangelo transitioned from President-Elect to President and Dr. Bob Newman is now Past President of the Chapter. Curt Francis, North Dakota Game and Fish Department, was elected as the president-Elect and Dr. Torre Hovick, North Dakota State University, and Levi Jacobson, North Dakota Game and Fish Department were elected as new Executive Board members.

During the Thursday evening Awards Banquet the Chapter presented the following Awards: Two 2024 Undergraduate Scholarships, Two 2024 Graduate Student Scholarships, Bill Bicknell Scholarship Award, Charles Pulver Case of the Year Award, North Dakota Wildlife Habitat Award, North Dakota Award (Professional Award), Outgoing President's Award

The NDCTWS Executive Board approved a donation of \$400 to CMPS which will be matched by a private donation. Grasslands and grouse were identified as shared resources in all seven CMPS states. CMPS was encouraged to increase its funding in the future.

The Chapter has been seeking to employ a Lobbyist during the ND Legislative sessions and that was discussed once more. The NDCTWS is supportive of the CMPS By-Laws change that is being proposed.

Has about 30 registrations so far, abut expects that should pick up. Wondered if Andrea Orabona would be able to do the Quiz bowl and WOW panel. Suggestion to make some parts virtual to improve participation/attendance (e.g. CMPS annual member meeting, getting more

CMPS 2024 Annual Business Meeting - 21 Mar 2024, 12:00-1:00 pm MDT, Rapid City, SD

Virtual Presentation – Ed Arnett, CEO of the Wildlife Society

Mr. Arnett gave a presentation on the development of TWS Strategic Plan 2024-2029. As he started, he mentioned the availability of the 2023 TWS Annual Report, and the 2024 TWS Annual Meeting in Baltimore.

A core group of TWS representatives and staff are using the vision and mission of TWS to build the strategic plan. The vision of TWS is as follows: The Wildlife Society is a strong and effective voice in representing wildlife conservation and management and ensuring sustainable wildlife populations in healthy ecosystems. The mission of TWS is "to inspire, empower, and enable wildlife professionals to sustain wildlife populations and habitats through science-based management and conservation.

Mission priorities are to build a community of meaningful connections between wildlife professionals across a diverse network, support professionals by effectively disseminating credible, science-based resources, and exercise external influence through increasing public engagement and interest in wildlife.

Implementation of the strategic plan will begin in FY2025 (which begins July 1).

Stephanie Ferrero kicks off CMPS annual business meeting by thanking SDTWS and program committee for putting the conference together and issues a shout-out to the NDTWS for donating \$400 to CMPS, a donation that received a \$400 private match.

Reported that CMPS Sandfort Student Travel grants supported 6 students from 4 of the 7 Section states to travel to the TWS Annual Meeting in Louisville, KY. CMPS allocated \$1700 to assist students with costs associated with attending the meeting.

CMPS worked with state chapters to appoint a liaison from each state to attend CMPS board meetings. This greatly improved communication between CMPS and state chapters.

CMPS was an active participant in the Conservation Affairs Network and wrote a letter supporting NDTWS opposition of a bill that would have limited ND Game and Fish ability to effectively manage wildlife.

CMPS established a PayPal account to allow for easier payment for sponsored events and donations.

CMPS wrote a letter to TWS regarding certification and scholarship, providing ideas to increase relevance of certification to members and to encourage more members to pursue certification.

Results of last CMPS board elections

Embere Hall was elected to the office of President-elect, and Heidi Plank & Rick Warhurst were selected to fill atlarge board positions. Anna Ortega was appointed to fill the vacant Vice President position.

Ferrero asked for a motion to destroy the ballots from the election. Mandy Pearson moved to destroy the ballots from the 2023 CMPS board elections, second by Phil. Motion carried by voice vote.

Minutes from a very abbreviated 2023 CMPS Annual Membership Meeting were shared with members. Highlights were 13 Sandfort Student Travel grants to assist students attending the TWS meeting in Spokane and establishment of a liaison position for each state in the Section to the CMPS board. The CMPS current financial statement was

provided to membership, as well as an approved budget. Rick Warhurst moved to approve the 2023 Annual Meeting minutes, second by Mandy Pearson and the motion passed by voice vote. Andrea Orabona made a motion to approve the 2024 CMPS budget presented, second by Brady Neiles; this motion also passed.

Heidi Plank, Mark Lindvall, and Marianne Mann are working to complete a budget audit but were not finished at the time of the annual meeting. Audit was later completed, and no problems or inconsistencies were found with the CMPS account. Mark shared an audit form that will likely be of use for conducting the audit, helping to improve consistency and provide documentation of the audit.

A quick update of the Mission and Strategic plan was presented, with a focus on pending bylaws revisions including restructuring the CMPS board. Under the proposed changes, each state would elect a member to the CMPS board, and these members would fill the role of committee chair for CMPS standing committees and Secretary. Treasurer would become a stand-alone, elected position and CMPS president would become a three-year position, serving one year each as President-elect, President, and Past president, with the office of Vice President eliminated. Each board position (with the exception of President-elect, President, past president) would serve a 2-year term. State chapters have the option of filling the state representative to CMPS either with an added candidate during their elections or having an existing board position fill this job as a role; only caveat is that the representative needs to be elected.

The Annual meeting moved past allotted time, so a motion to bring the meeting to a close was called for. Andrea Orabona moved to adjourn the 2024 CMPS annual meeting, seconded by Silka Kempema. Meeting adjourned at 1:13 MDT.

State Chapter liaisons and representative's updates

North Dakota – Rick Warhurst: Not much to report; board meeting coming up & Rick is planning to attend.

South Dakota – Brady Neiles: Combined annual meeting of SDTWS & CMPS went well. Brady will continue as SD liaison to CMPS. SDTWS is still seeking a candidate for president-elect. Brady said that a lot of the older wildlife professionals in SD have served as president in the past (and don't want to run again) and younger professionals have not expressed much interest in TWS. Also seems to be some reluctance to serve by federal employees – not sure what the situation is here but may be able to have Heidi (USFS) talk with some SD federal folks. Reported attendance of 57-65 people, lower than usual likely in part because of the Midwest Fish and Wildlife Conference in January. SDTWS/CMPS Combined Annual Meeting 20-22 Mar 2024. The meeting went quite well, and CMPS was represented by Stephanie Ferrero, Rick Warhurst, Andrea Orabona, and Mel Nenneman. The Quiz bowl evening was very successful, with nearly everyone at the meeting participating in a fun, social evening of wildlife trivia and professional networking. Andrea Orabona did a lot of work preparing questions for the quiz bowl, getting people signed up on teams, generating a bracket for the evening and serving as the host. Andrea has donated the buzzer system to CMPS so it is available for future meetings. Rick Warhurst, Denny Mann, Stephanie Ferrero, Anna Ortega, and Embere Hall (and probably some I missed) did a fantastic job coming up with donated items for the auction, making this one of the most successful fundraisers that CMPS has had. Dave Haukos provided a certification workshop for ~10 people at the SDTWS/CMPS annual meeting. He provided a similar workshop at the Midwest Fish and Wildlife Conference in Jan. Mandy Pearson (SDTWS treasurer) sent CMPS details of the costs for the lunch during the business meeting, and a detailed report of CMPS auction income. Action: Stephanie will forward this email to the CMPS board. The WOW event at the SDTWS annual meeting was a 1st for the chapter.
